Meeting Highlights

1. Harvey Correia RD2067 (Brannon Island) and Vice Chair of the NDGSA as well as Craig Nakahara, RD 501 (Ryer Island), joined to observe a meeting and get a sense for the Collaborative as they decide how they want to move forward outside of the NDGSA.
 - a. RD 3, 317, 407, 501, 554, 556, 2011, 2067 have thus far given notice of withdrawing from NDGSA. At the board meeting on May 22nd NDGSA members will discuss the current Reclamation Districts and whether they will remain to pursue work in the GSP as the NDGSA.

2. Luhdorff & Scalmanini gave a general update on GSP development and highlighted key areas of focus for March and April, including data collection for the preliminary water budget. You can view the [GSP Status Report here](#).
3. Collaborative members discussed the draft basin prioritization recently released by DWR. DWR has elevated Solano Subbasin to a high priority subbasin. The Solano GSA and Luhdorff & Scalmanini will be submitting a comment letter on behalf of the Collaborative in response to this elevated draft prioritization.
