Meeting Highlights:

1. Bryan Thoreson of Davids Engineering (DE) did a presentation on [the preliminary water budget with GSA comments](#). The group learned more about the model's capacity for representation of deep percolation and the textural/ spatial differences in subsurface layers. DE and LSCE shared that ultimately, the water budget would present a dynamic picture of the groundwater picture using SVSim (which represents 9 layers).
 - a. **Group Decisions:**
 - i. During GSP implementation, annexations and de-annexations between SID and the cities of Dixon and Vacaville must be tracked-- this will change overall water model.
 - ii. Add 1.5 AF/ domestic well

- iii. Estimate 0 for Delta agricultural wells with the assumption that the few that exist aren't being used.
 - iv. Will use DICU data and establish rationale for that decision.
- 2. Becky Rittenberg gave a presentation on stakeholder outreach to DAC and SDAC by The Freshwater Trust and Local Government Commission in 2019. Collaborative members learned more about their approach, sources used, and alternative ways of designating social vulnerability.
- 3. Ag Innovations and Collaborative members compiled a list of resources and potential candidates for the Citizen Advisory Committee. Ag Innovations will send a letter to Collaborative members to send to potential candidates.
