MEETING HIGHLIGHTS

1. The public commenting period for the draft GSP ended on November 15. Comments were received from 7 total commenters. The technical team does not anticipate needing to make significant changes to the GSP in response to comments received. The technical team is preparing a comment log with all received comments and responses to each comment.
2. The Solano Collaborative discussed comments and the timeline for finalizing the GSP by December 1 to send to GSA boards. All GSA boards that are a part of the Collaborative plan to hold public hearings to adopt the GSP in December.
3. Members discussed the status of GSA Board adoption from the remaining independent Reclamation District GSAs. RDs 2111 and 3 will be meeting December 1. RD 349 will be meeting December 14. RD 554 and RD 556 have not yet confirmed their GSA board meeting date. The engagement team will follow up with their coordinator to confirm this date.
4. Jenn Fox reported on stakeholder engagement and the November 9 Solano Groundwater Sustainability Plan (GSP) Virtual Town Hall. There were 81 participants and [here](#) is a link to the Meeting Summary. The Collaborative members shared perspectives on what worked well about the event and what might be improved.
