HIGHLIGHTS

1. **GSA updates:** Chris Hunley is the new Groundwater Sustainability Manager for Sacramento County Department of Water Resources.



2. a) **GSP Implementation - Monitoring:** The technical team of Luhdorff & Scalamini Consulting Engineers (LSCE) is developing a guidebook for basin-wide and GSA-specific monitoring activities and producing an interactive website of monitoring locations.

GSP Implementation - Boundary Map: A new interactive map of the GSAs in the Solano Subbasin is available at www.SolanoGSP.com. The map helps viewers determine which GSA covers a specific location.
- b) **GSP Implementation - Grant Opportunities:** In preparing for the opening of DWR's Round 2 Solicitation for SGMA Implementation Grant funding, Solano Subbasin GSAs will be discussing priorities and feasibility for implementation projects, management actions, and related activities
- c) **GSP Implementation - Charges:** Presentations are being made to agencies and organizations regarding GSP implementation and related charges. Upcoming meetings include the June 29 Virtual Town Hall, and the July 14 Solano GSA Prop 218 Public Hearing.
3. **Implementation MOU:** Adjustments have been made to the draft Implementation MOU, and GSAs are presenting the MOU to their Boards for approval.
4. a) **Well Permitting - Executive Order (EO):** Solano and Sacramento Counties are developing approaches to comply with Section 9 of the Governor's EO N-7-22. The counties are working to minimize delays and costs associated with processing well permit applications.

b) **Well Permitting - Assembly Bill (AB) 2022:** Proposed legislation would require reviews of all well applications including possible interference with existing wells. A 30-day notice is also proposed for all well applications, including emergency replacements.
5. **Stakeholder Engagement:** Building from the May 3 Virtual Town Hall (VTH), the June 29th VTH will include presentations and a question/answer session relating to charges for the Solano GSA. Registration is currently at 50 people.
